BILL100 – Introduction to CMS and Medicare

Description: This course offers an introduction to the Medicare program and the Centers for Medicare and Medicaid Services (CMS).

BILL101 – Intake Process Prior to Delivery

Description: This course introduces the biller to the intake process. It offers suggestions to help make the process more efficient and effective to reduce delays and denials.

BILL102 – Documentation Prior to Claim Submission

Description: This course highlights Medicare documentation requirements prior to claims submission. It is important to understand which type of order is required prior to delivery: Preliminary/Dispensing Order (can be verbal or written) or Detailed Written Order Prior to Delivery.

BILL103 – Orders, CMNs and DIFs

Description: This course introduces the various types of orders required by Medicare: Preliminary/Dispensing Order, Written Order Prior to Delivery (WOPD), Detailed Written Order (DWO), Certificate of Medical Necessity (CMN) and DME MAC Information Form (DIF). You will learn how to know when you use which type of order, how to correctly complete orders, and who is authorized to order durable medical equipment.

Description: This course will guide you through the information required prior to submitting a claim and the correct ways to submit a claim. You will also learn the different types of claims.

BILL110 – Power Mobility Devices: Understanding the Process

This course will explain the changes related to power wheelchairs and POVs, collectively referred to as power mobility devices, or PMDs.
